Therefore, the topics covered will include the use of state-of-the-art equipment, such as, CBCT imaging, specialized treatment planning software, intraoral scanning, 3D printing of surgical guides, and the use of autologous, concentrated growth factors, PRF.

POLICY AND IMPORTANT INFORMATION

- 50% of registration fee is due at time of registration for the Brighter way course.
 This is important because all Brighter Way live surgical programs are only two to eight dentists.
- Brighter Way's cancellation fee is \$500 up to forty-five (45) days prior to each
